**Sub: Release of fund for procurement of Bio-larvicide and Chemical larvicide for prevention of Dengue in 2022**

Madam,

**Administrative Approval** was accorded in favour West Bengal Medical Services Corporation Limited (WBMSCL) for procurement of 60156 litre of chemical larvicide (Temephos), 73644 Kg of bio larvicide (Strain 164) and 59976 Kg of bio larvicide (Strain ABIL) for use in rural areas in the year 2022 vide this Department's order No. 83-HFW-18049/19/2018-PHP dtd 11.03.2022.

Now, Managing Director, WBMSCL, vide communication numbers mentioned under reference, has informed this Department that Award of Contract had been issued to selected agencies for procurement of larvicides and placed requisition of fund amounting Rs 21,87,42,715 for the said procurement.

In view of above, the undersigned is directed by the order of the Governor to say that the Governor has been pleased to accord Administrative Approval of Rs 21,87,42,715 and Financial Sanction of Rs **8,55,68,860 (Rupees eight crore fifty five lakh sixty eight thousand eight hundred sixty only)** in favour of West Bengal Medical Services Corporation Limited (WBMSCL) for Procurement of Larvicide and supply the same to the rural areas to control Dengue in 2022.

The fund will be released from the head of Account **24-2210-06-101-056-31-02** in the current Financial Year 2022-23.


The balance amount of Rs 13,31,73,855 will be released in due course out of the available sources.

The fund sanctioned hereinabove is released and placed at the disposal of the Assistant Secretary and Drawing and Disbursing Officer, Department of H&FW Government of West Bengal who will act as the Drawing and Disbursing Officer for this purpose. **The Drawing and Disbursing Officer shall disburse the funds in favour of the West Bengal Medical Services Corporation Limited by transfer credit to the deposit Account of the WBMSCL with Kolkata Pay & Accounts Office-III.**

This order is issued in exercise of power delegated under **Finance Department Group N Budget Branch vide their U.O. No. 0381 dtd 2.5.2022** and read with the concurrence of this Department's Financial Advisor Branch's UO No. 189 dtd 13.6.2022


