
ORDER

KNOW ALL MEN BY THESE PRESENTS THAT I daughter of resident of in the district of..... at present employed as in the Department of Health and Family Welfare under West Bengal Nursing Service (herein called the "Employees") do hereby bind myself and my heirs, executors and administrators to pay to the Directorate of Health Services, Govt. of West Bengal (hereinafter called the "Government") on demand the sum of Rs.1,00,000/-(Rupees One lakh) together with the interest thereon from the date of demand at Government rates for the time being in force on Government loans or, if payment is made in a country other than India, the equivalent of the said amount in the currency of the country converted at the official rate of exchange between that country and India AND TOGETHER with all costs between attorney and client and all charges and expenses that shall or may have been incurred by the Government.

WHEREAS I have been granted T. R. / Study Leave by Government ;
AND WHEREAS for the better protection of the Government I have agreed to execute this bond with such condition as hereunder is written ;

NOW THE CONDITION OF THE ABOVE WRITTEN OBLIGATION IS THAT in the event of my failing to resume duty ,or resigning or retiring from service or otherwise quitting service without returning to duty ,after the expiry or termination of the period of T.R. / study leave or at any time within a period of three years after my return to duty , I shall forthwith pay to the Government or as may be directed by the Government on demand the said sum of Rs.1,00,000/-(Rupees One lakh) only together with interest thereon from the date of demand at Government rates for the time being in force on Government loans ;

AND upon my making such payment the above written obligations shall be void and be of no effect, otherwise it shall be and remain in full force and virtue.

The Bond shall in all respects be governed by the laws of West Bengal for the time being in force and the rights and liabilities hereunder shall, where necessary, be accordingly determined by the appropriate Courts in India.

The Government of West Bengal have agreed to bear the stamp duty payable on this bond.
