ORDER

Like previous years, Action Plan has been prepared to tackle Dengue in the urban areas of the State in the year 2021. It has been decided that House to House Survey works would be done on fortnightly basis in urban areas during the period May'21 to Nov'21 (total 14 rounds). Vector control activity in vulnerable areas would be done during the period May'21 to November'21 on weekly basis (total 28 rounds). State Urban Development Agency (SUDA) has requested to release fund for payment of honorarium to Dengue House to House survey workers, DEAs deployed for the period May'21 to November'21. They have also requested to release fund for contingency and mobility support at ULBs for this period.

In view of above, the undersigned is directed by the order of the Governor to say that the Governor has been pleased to accord Administrative Approval and Financial Sanction to the tune of **Rs 44,91,65,650** (Rupees forty four crore ninety one lakh sixty five thousand six hundred fifty) only in favour of the Director, State Urban Development Agency(SUDA) for payment of the following items:


