ORDER

Secretary, School Education Department requested this Department to sanction and release Rs. 2.34 crore to meet up printing cost of Health Cards and Referral Slips for school children used at schools by the School Health Teams. Accordingly, Rs. 81.05 lakh was sanctioned from National Health Mission (NHM) and released to the bank account of Paschim Banga Samagra Shiksha Mission. It was decided that balance fund of Rs. 1.53 crore would be provided from the State Budget.

In view of above, the undersigned is directed by the order of the Governor to say that Governor is pleased to accord Administrative Approval and Financial Sanction of Rs 1,53,00,000 (Rupees one crore fifty three lakh) only in favour of Paschim Banga Samagra Shiksha Mission in the Financial Year 2018-19.

The amount is debitable to the Head of Account "24-HF-2210-01-110-008-31-02" in the State Budget during the current financial year 2018-2019.
