The Governor was pleased to sanction and release total **Rs 58,37,60,000** till date in favour of the Managing Director, West Bengal Medical Services Corporation Limited as matching State Share for development of 2nd Campus of Chittaranjan National Cancer Institute at Rajarhat vide order No.1049(sanction)/HF/P/P&B/PHP/5C-04/2012 dtd 27.02.2015, Order No. 570-(Sanction)/HF/P/P&B/PHP/5C-04/2012 dtd. 28-06-2016, No. 2357 (Sanction)/HF/P/P&B/PHP/5C-04/2012 dtd 22.3.2018 and No. 2005/(Sanction) HFW-18021/5/2018-PHP dtd 26.1.2.18.

Now, the undersigned is directed by the order of the Governor to say that the Governor has been pleased to accord Administrative Approval and Financial Sanction to the tune of **Rs 2,79,73,333 (Rupees two crore seventy nine lakh seventy three thousand three hundred thirty three) only** in favour of West Bengal Medical Services Corporation Limited as matching state share towards development of 2nd Campus of Chittaranjan National Cancer Institute at Rajarhat.


