Order

Administrative Approval was accorded in favour of West Bengal Medical Services Corporation Limited (WBMSCL) for procurement and supply of 63,498 litre of chemical larvicide (Temephos), 73,524 kg of Bio larvicide (Strain 164) and 60,156 kg of biolarvicide (Strain ABIL) for 3342 Gram Panchayats across the State for prevention of Dengue in the year 2021 vide this Department's order No 22-HFW-18049/19/2018-PHP dtd 22-01-2021.

Managing Director, WBMSCL has informed that Award of Contract had been finalized and issued to selected agencies for procurement of Bio larvicide (Strain ABIL and Strain 164). Managing Director, WBMSCL has also requested this Branch for release of Rs 16,53,34,822 in favour of WBMSCL for procurement and supply of Bio larvicide as mentioned above.


In view of above, the undersigned is directed to say that the Governor has been pleased to accord Administrative Approval and Financial Sanction of Rs 16,53,34,822 (Rupees sixteen crore fifty three lakh thirty four thousand eight hundred twenty two) in favour West Bengal Medical Services Corporation Limited (WBMSCL) for procurement and supply of 73,524 kg of Bio larvicide (Strain 164) and 60,156 kg of Bio larvicide (Strain ABIL) to rural areas for control and prevention of Dengue in the year 2021.

The fund will be released from the head of Account 24-HF-2210-06-800-002-31-02 in the current Financial Year 2021-22.

The fund sanctioned hereinabove is released and placed at the disposal of the Assistant Secretary and Drawing and Disbursing Officer, Department of H&FW Government of West Bengal who will act as the Drawing and Disbursing Officer for this purpose. **The Drawing and Disbursing Officer shall disburse the funds in favour of the West Bengal Medical Services Corporation Limited** by transfer credit to the deposit Account of the WBMSCL with Kolkata Pay & Accounts Office-III.

This order is issued in exercise of power delegated under Finance Department Group N Budget Branch vide their U.O. No. 0377 dtd 11.05.2021 and read with the concurrence of this Department's Financial Advisor Branch's UO No. 77 dtd 25.5.2021.
