NOTIFICATION

West Bengal Medical Services Corporation Limited (WBMSCL) has been entrusted with Planning, Designing and Construction of a Degree College of Yoga & Naturopathy within the premises of Belur State General Hospital, Howrah in terms of this Department's e-file no. HFW-41014(12)/2/2018-WBMSCL SEC-Dept. of H&FW-Part (1). It has also been decided that construction of the Institution would be taken up by WBMSCL in turnkey mode, as was done in case of the recently constructed Multi/Super Specialty Hospitals. After careful consideration of all the issues involved, I am directed to inform that the Governor has been pleased to constitute the following Project Implementation Committee (PIC) for finalizing all technical parameters of the project in keeping with the extant guidelines in the matter:

It is also decided that the aforesaid Project Implementation Committee (PIC) would consider, finalize and approve all technical issues related to the Project, as may be placed before it, including inter alia, the following:-

- a. Pinpoint the site selection for the Institution
- b. Distribution of Services and Facilities among the buildings proposed to be constructed.
- c. Space requirement and Floor-wise distribution for various Facilities and Services
- d. Employer's Requirement section of the Tender Document.
- e. Requirements of Medical Equipment and furniture, fixture etc.
- f. Architectural design and drawings as and when required.
- g. Schedule of usage of different services areas and utilities.
- h. Building and Floor wise lay out plans.
- i. Engagement of outsourced Consultant(s) for obtaining expert advice.

Any other member as decided by the Committee may be invited to the meetings of the PIC as invitee members if required. WBMSCL would also provide required secretarial, mobility and logistic support to the PIC.
