ORDER

Yellow Fever vaccination centre was commenced at North Bengal Medical College and Hospital (NBMCH) vide this Department's order No 677-HFW/18033/1/2018-PHP dtd 9.12.2019. Medical Superintendent cum Vice Principal, NBMCH placed requisition of fund for procurement and payment charges of vaccines.

In view of above, the undersigned is directed by order of the Governor to say that the Governor has been pleased to accord Administrative Approval and Financial Sanction to the tune of **Rs 87,132 (Rupees eighty seven thousand one hundred thirty two)** only in favour of Medical Superintendent cum Vice Principal of North Bengal Medical College and Hospital for procurement and payment charges of Yellow Fever vaccines from Central Research Institute, Kasuali.
