Under National Quality Assessment Programme, an External team based assessment was carried out in Balurghat DH in June 2019, but in the said State assessment the hospital scored below 70% in the Departments of Radiology, Pharmacy, Laboratory, and Emergency and also scored below 70% in five areas of concern including Quality Management.

So, a fresh State assessment will be conducted in Balurghat District Hospital to see whether all gaps have been covered by hospital authority within this period and then a decision will be taken to finalise the hospital's name for External assessment.


The External assessment team will comprise of Consultants from other Districts, who will visit the facility for two days on and from 10.12.2019 till 11.12.2019 as per roster given in Annexure A and will complete the assessment as per DH checklists. They will prepare gap closure report of previous State assessment.

State Consultant (QA), State Consultant (PH) and State Consultant(QM) will also visit Balurghat DH during the said period and will examine and prepare report on preparedness of Balurghat DH for External assessment.

For travel to Balurghat DH, train tickets will be purchased by State NHM supported QA division for all Consultants moving. For stay at Balurghat, CMOH Dakshin Dinajpur district will arrange for boarding and local travel.

All costs of travel for movement of assessment team will be paid out of 13.1.2 (Quality Assurance Assessments -State and District level assessment cum mentoring visits) of ROP 2019-20.

This has approval of Mission Director, National Health Mission, West Bengal.


