ORDER

To combat probable 3rd surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. Thus, PWD and other concerned agencies have been requested to take up requisite civil and electrical works at the concerned health facilities. Accordingly, estimate has been received from Superintendent, Habra SGH, North 24 Pgs with request to issue AAFS.

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of Rs. 24,25,579 (Rupees twenty four lakh twenty five thousand five hundred seventy nine) only in favour of West Bengal Medical Services Corporation Ltd for executing the below mentioned work:

5. Works will be taken up by the respective PWD offices/agencies. Managing Director, West Bengal Medical Services Corporation Ltd is requested to kindly sub-allot the fund to concerned agency.

6. The utilisation certificate will be submitted by the organisation in format of GFR-12C to State FMG, NHM, WB.

7. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and data entry in NHM-PMS portal must be ensured by the concerned facility.

8. This is issued with the approval of Mission Director, NHM & Secretary of this Department.


