ORDER

In pursuance to G.O. No. HF / O / MA / 641 / HFW - 25099 / 54 / 2021 - MA dt. 06.04.2021 approval is given to allow STUDY LEAVE in respect to Smt. Aindrila Maji posted as G.D.M.O., SNCU at Chittaranjan Seva Sadan for a period of 12 (twelve) months with effect from 01.03.2021 to 28.02.2022 for pursuing the course of Post Graduate DNB (Paediatrics) at Tata Main Hospital, Jamshedpur, Jharkhand observing Rules under West Bengal Service Rules Part I, Appendix No. 5, Clause 2 (a). After exhaust of 12 (twelve) months with effect from 01.03.2021 to 28.02.2022 if her STUDY remains incomplete she may apply for extension of STUDY LEAVE for another 12 (twelve) months or completion of the course whichever is earlier.

1. The leave salary during the STUDY LEAVE will be as per West Bengal Service Rules Part I, Appendix No. 5, Clause 7 (2).
2. The candidate will have to execute a Bond as per prescribed Form 2 in terms of West Bengal Service Rules Part I, Appendix No. 5.
3. The candidate will have to render full clinical services for patient care in the institution where she is allowed for STUDY.
4. During the period of STUDY LEAVE the officer will draw Pay & Allowances from the institution from which she has been released for the STUDY, after submission of proper and regular working statement from the institution where she would take her course of STUDY.
5. The Medical Officer permitted for STUDY LEAVE, may be released by local arrangement by the concerned local authority to enable her to join her course of STUDY as soon as possible. The concerned M.O. would handover charges at the local level as directed by the controlling authority.

All concerned are being informed accordingly.


