NOTIFICATION

No. 368/HF/CFS/2A-1/2011 dated, Kolkata the **9th November, 2021**—In accordance with Section 31(2) of the Food Safety and Standards Act, 2006 every Petty Food Business Operator shall register themselves with such authority and in such manner as may be specified by regulations, without prejudice to the availability of safe and wholesome food for human consumption or affecting the interest of the consumers.

In view of above and in cancellation of this Department's Notification 290/HF/CFS/2A-1/2011 dated 06.09.2021 Mr. Kamal Kanti Bhuia, Food Safety Officer posted at Kolkata Municipal Corporation is hereby directed to act as Registering Authority of Borough IV (Ward 21,22,23,24,25,26,27,28,38,39) of Kolkata Municipal Corporation instead of Mr. Mukunda Behari Goswami, Food Safety Officer, Kolkata Municipal Corporation for Petty Food Business Operators as required under regulation 1.2.1(5) of Food Safety and Standards(Licensing and Regulation of Food Businesses), Regulation, 2011, until further notification.

Mr. Kamal Kanti Bhuia will continue to act also as Registering Authority of Borough V (Ward 36,37,40,41,42,43,44,45,48,49,50) of Kolkata Municipal Corporation in accordance to the Notification 178/HF/CFS/2A-1/2011 dated 22.06.2021 for Petty Food Business Operators as required under regulation 1.2.1(5) of Food Safety and Standards(Licensing and Regulation of Food Businesses), Regulation, 2011.
