Sub: Supply of Cooked Diet to Different Government Hospitals

Sir,

I am directed to refer to the subject mentioned above and to state that in compliance of the Orders of Hon'ble High Court, Calcutta dated 21.08.2009 in W.P. No. 11766 (W) of 2009 and dated 30.03.2017 in W.P. No. 9208 (W) of 2017 Hon'ble Governor has been pleased to approve the revision of rates for cooked diet supplied to the indoor patients of different Government health facilities vide no. 292(2)-HF/O/MS/W-06/17 dated 27.07.2017 (copy enclosed for perusal). However, the said Order was challenged by the Writ Petition bearing no. W.P. 21719/W of 2017 in the court of the Hon'ble Ld. Justice Debangshu Basak. In response, this office has issued a Corrigendum to the previous Memo was issued vide No. 363-MS/HF/O/MS/W-06/2017 dated 12.09.2017 and moved an application before the Hon'ble Court defending her side.

Since this office cannot issue fresh work order following tender till leave of the Hon'ble Court is obtained, I am, hereby, directed to request you to inform this office whether your Department with the help of the SHGs (including Maha Sangha) may take up the work of supply of cooked diet during the interim period to the indoor patients in those hospitals where the existing terms of contract have expired or will expire on 30th September 2017. A list of such health institutions is enclosed for your kind perusal.

Sub: Revision of Rates of Cooked Diet

MEMO

In compliance of the Orders of Hon'ble High Court, Calcutta dated 21.08.2009 in W.P. No. 11766 (W) of 2009 and dated 30.03.2017 in W.P. No. 9208 (W) of 2017, Broad Based Committee was constituted to review and determine the rationalized rate of cooked diet taking into account the present market value of dietary articles, for supply to the indoor patients of different Government facilities. The Committee last reviewed the rates in April, 2017.

After careful review of constant increase in the price index and with a view to provide better diet to the patients, Governor has been pleased to approve the revision of rates for cooked diet supplied to the indoor patients of different Government health facilities in partial modification to earlier Government Order issued by this Department vide no. HF/O/MS/1032/W-14/10 dated 10.11.2014 in the following manner:
