2. The condemned Vehicle and Two Wheelers, unserviceable Tyre, Scraps & Used Engine Oil should be disposed off immediately by inviting sealed tender only to the highest bidders subject to the said reserve price and to the best advantage to the Govt. after due observation of the Financial Rules. A notice regarding such auction of the condemned materials will have to be published in two leading dailies, one being Bengali and other English at least 15 (Fifteen) days before the date of auction.

3. Each tenderer will have to deposit the amount as earnest money against each of the asserted vehicle and unserviceable Tyre and Scraps as mentioned at pre page and above to the Head of Account "8443-Civil Deposits -00-103-Security Deposits-001-Earnest/ Security Money- 07—deposits".

4. Inventory in respect of all the Vehicle and Two Wheelers, unserviceable Tyre, Scraps & Used Engine Oil declared condemned under the order will have to be made under supervision of an officer not below the rank of Regional Health Transport Officer before disposal.

5. The D.D.H.S. (Transport) will be the authority for disposal of the said condemned Vehicle and Two Wheelers, unserviceable Tyre, Scraps & Used Engine Oil. He should take immediate steps for quick disposal of these condemned Vehicle and Two Wheelers, unserviceable Tyre, Scraps & Used Engine Oil with a view to avoid loss of Government money.


He is further allowed a maximum period of three month time for disposal of the work. If the condemned Vehicle and Two Wheelers, unserviceable Tyre, Scraps & Used Engine Oil remain unsold to the tenderer within the specific time of three months, fresh tender must again be invited under intimation to this Department.

6. The sale proceeds of the condemned Vehicle and Two Wheelers, unserviceable Tyre, Scraps & Used Engine Oil should be credited to the Govt. under the Head of Accounts "0210 – Medical & P.H. – 01 - Urban Health Services – 800-015-27-Other Receipts" in State Budget. The deposited sale proceeds against each of the condemned vehicles and unserviceable Tyre and Scraps must be intimated to the Department immediately after the disposal.

7. This Order is issued in terms of Transport Department G.O. No.5193/WT/RT/O/2M-12/03 Dated 29.11.2009 and this Department G.O. No. H/TDE/1181/V-28/95 Pt. 17.11.2005.

8. Other terms and conditions as stipulates within Department G.O. No. under reference are to be followed.

9. The Principal Accountant General, West Bengal and all other concerned are being informed.
