**ORDER**

PPP based laboratory unit was functional at Vidyasagar SGH, where tender was floated locally and approval accorded by this Department. Eskag Sanjeevani was the Partner. As per lab policy and notification by DHS, Hospital need to do all essential Lab tests with own HR and so minimal outsourcing to be followed with departmental approval. Payments for services were done from concession fees pool deposited with hospital. Due to lack of infrastructure for lab, all cases could not be conducted in house. As per high case load, running of 12 Bed HDU and also SARI cases, there was referral to the PPP based lab. Under free treatment policy all referred cases were free of cost and bills raised to hospital. This includes IPD, ER, HDU cases and selected OPD cases all of which was referred through hospital as per norms.

Now, as communication received from Superintendent, Vidyasagar SGH, bill amounting Rs. 30,64,315 is pending for payment to Eskag Sanjeevani as concession fees Pool is exhausted.

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of Rs. 30,64,315 (Rupees thirty lakh sixty four thousand three hundred fifteen) only in favour of **Chief Medical Officer of Health, South 24 Parganas** for payment of pending bills of 'Eskag Sanjeevani' for performing different tests (for detection and management) of Covid patients admitted at the Vidyasagar SGH.

**3. The fund is placed against the activity head, Essential Drugs for COVID19 Management (ECRP-II) [RoP Code: S.1.3] [Tally Code: SA.1.3] under ECRP-II.**

4. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund and he is requested to release the fund to South 24 Parganas District Health & Family Welfare Samiti.

5. Chief Medical Officer of Health, South 24 Parganas will sub-allot the fund to Superintendent, Vidyasagar SGH for arrange payment of bills to 'Eskag Sanjeevani'.

**6. The utilisation will be reflected by the institution in prescribed monthly FMR of ECRP-II, submitted to State FMG, NHM, WB.**

7. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and **data entry in NHM-PMS portal must be ensured by the concerned facility.**

8. This is issued with the approval of Mission Director, NHM & Secretary, Health & Family Welfare Department.


