ORDER

To combat Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. Accordingly, this Department has approved Set up 10 NICU beds at MSD MCH, 80 NICU beds at IPGMER and 10 bed NICU at Dr B C Roy PGIPS. Fund has been released to WBMSCL in phases after receiving requirement. Now, WBMSCL has placed requisition of Rs 10,92,97,256 for procurement of following 5 different types of equipment for these health facilities:

1. Neonatal radiant warmer for level III NICU Display name in GeM portal: Clinical Incubators or Infant Warmers (Qty:20)
2. LED neonatal phototherapy machine Display name in GeM portal: Phototherapy machine for SNCU (Qty:40)
3. Ventilator (neonatal) Display name in GeM portal: Neonatal Ventilator (Qty:34)
4. Rebound tonometer (Qty:1)
5. Neonatal incubator Bed with Weighing Scale (Qty:7)

2. In view of above, the undersigned is directed by the order of the Governor to accord Administrative Approval and Financial Sanction of **Rs. 10,92,97,256 (Rupees ten crore ninety two lakh ninety seven thousand two hundred fifty six) only** in favour of **West Bengal Medical Service Corporation Ltd** for procurement of 5 different types of equipment for 10 NICU beds at MSD MCH, 80 NICU beds at IPGMER and 10 bed NICU at Dr B C Roy PGIPS as mentioned above.

3. i) The fund of Rs. 9,00,00,000/- is placed against the activity head, ICU Beds added at other Public Healthcare Facilities (ECRP-II) [RoP Code: S.2.4.5] [Tally Code: SA.2.4.5] under ECRP-II.

ii) The rest fund of Rs. 1,92,97,256/- is placed against the activity head, ICU Beds added at Medical Colleges (ECRP-II) [RoP Code: S.2.4.1] [Tally Code: SA.2.4.1] under ECRP-II.

4. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund.

5. Managing Director, West Bengal Medical Service Corporation Ltd is requested to arrange payment to the concerned supplier/agency by observing existing financial norms.

6. The utilisation certificate will be submitted by the organisation in format of GFR-12C to State FMG, NHM, WB.

7. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and data entry in NHM-PMS portal must be ensured by the concerned facility.


