
ORDER



3. Fund will be released after submission of requisition of fund along with the statement of work awarded cost for each facility in favour of **District Health & Family Welfare Samity, Hooghly** as the implementing agency.
4. The released amount shall be treated as a pool fund for the said activity.
5. The expenditure shall be booked in the monthly FMR & will be submitted to this end in due course.
6. No price escalation will be allowed in any circumstances.
