MEMO

To overcome the acute crisis of teachers and to abide by the CCIM guideline, the undersigned has been directed to allow **purely on temporary basis** the following SAMOs, AMOs, Lecturers and Readers having requisite qualification, posted in different Ayurvedic units or Institutions to act as teaching faculty at two Institutions namely, (i) Institute of Post Graduate Ayurvedic Education & Research at Shyamadas Vaidya Sastrapith (IPGAE & R at SVSP), Kolkata and (ii) J.B.Roy State Ayurvedic Medical College & Hospital, Kolkata as shown against their names. This is totally a temporary arrangement and no financial benefit will be enjoyed by the incumbents concerned.

The allotment of duties of the teaching faculties will be made by the Authorities of the Institutions.
