**MEMORANDUM**

The undersigned is directed by order of the Governor to say that the Governor has been pleased to permit the **7(seven)** Medical Teachers of the West Bengal Medical Education Services as shown in the Annexure to undertake **Postgraduate** Course of studies and training, in different disciplines as noted against each, under the West Bengal University of Health Sciences for the **Session 2021** and for that purpose the Governor has also been pleased to place them on the Trainee Reserve for the period of **three years** with effect from the date(s) of their release from their present place(s) of posting or till the completion of the University examination of the course(s) for the first time whichever is earlier.

2. The Medical Teachers will draw pay and Pay & Allowances as admissible to them while posted in such Trainee Reserve posts in such manner as they drew at the time of their release from their present place of posting.

3. The Medical Teachers placed on Trainee Reserve is subject to the condition that they shall prior to their drawing Pay as Medical Teacher on T.R Officer, execute bonds in triplicate in the prescribed form undertaking to serve this State Government for a period of at least **five years** after completion of the course. The duly filled up bond should be submitted to Special Secretary (MERT) for acceptance.


4. The Medical Teachers placed on Trainee Reserve may be released by local arrangement from their present place of posting by the Concerned Controlling Authority, in order to enable them to join the course.

5. Meanwhile, if on scrutiny and vigilance verification, any candidate is found to have been suppressing facts or furnishing false information, or in case of any adverse report, his candidature will liable to be cancelled and appropriate administrative action will be initiated against.

6. The Joint Director of Health Services (Accounts) will act as the DDO in this regard while the Deputy Director of Medical Education, West Bengal shall act as Controlling Officer in respect of such Medical Teachers.

7. The Pay & Accounts Officer – III, Kolkata, Pay & Accounts Office – III, Accountant General, West Bengal and other concerned are being informed.

8. They shall obtain release order from the concerned Institution immediately after completion of the course and report to the Director of Medical Education, West Bengal for duties.








