**ORDER**

The Department of Health and Family Welfare, Govt of West Bengal decided to construct permanent Covid Units at different health facilities under the ECRP-II fund for management of Covid-19 patients. Accordingly, Rs 307,76,54,905 was sanctioned to CMOHs for allotment to PWD for construction of 16 numbers of 100-bed Covid wards, 4 number of 50-bed Covid wards, 113 numbers of 20-bed Covid wards at different hospitals vide order No HFW-18033/1/2022-PHP/1279 dtd 7.4.2022. Accordingly, fund release order of Rs 74,37,90,674 was issued and subsequently released to concerned districts through WBSH&FW Samiti vide No HFW-18033/1/2022-PHP/Pt-I/2886 dtd 5.8.2022. Now, Chief Medical Officers of Health, Malda and South 24 Parganas has placed Utilization along with Statement of Expenditure and placed requisition for balance fund in this purpose.

In view of the above, the undersigned is directed to release the balance fund of **Rs. 16,06,25,480 (Rupees sixteen crore six lakh twenty five thousand four hundred eighty)** in favour of **CMOH, Malda and South 24 Parganas**, as mentioned in the table below for construction of Covid wards in Malda and South 24 Parganas in accordance with AA&FS No HFW-18033/1/2022-PHP/1279 dtd 7.4.2022 followed by fund release order No HFW-18033/1/2022-PHP/Pt-I/2886 dtd 5.8.2022.
