ORDER

Like previous years, Action Plan has been prepared to tackle Dengue in the urban areas of the State in the year 2022. House to House survey plan has been prepared by State Urban Development Agency (SUDA). It has been decided that House to House Survey works would be done in urban areas during the period July'2022 to November'2022 (5 days/round, total 10 rounds). Vector control activity would be done during the period July'2022 to November'2022 on weekly basis (6 days/round, total 18 rounds).

Now, State Urban Development Agency (SUDA) has requested to release the following funds:

- a) Fund for payment of honorarium to Dengue House to House survey workers, DEAs deployed for the period July'2022 to November'2022.
- b) Fund for contingency, mobility support to ULBs for this period
- c) Balance fund required for payment of honorarium to House to House Team Members, Supervisors for conducting 2 additional rounds House to House Activities during the month of November 2021 .

In view of above, the undersigned is directed by the order of the Governor to say that the Governor has been pleased to accord Administrative Approval and Financial Sanction to the tune of **Rs 33,32,63,070 (Rupees thirty three crore thirty two lakh sixty three thousand seventy)** only in favour of the Director, State Urban Development Agency(SUDA) for payment of the following items:
