NOTIFICATION

Some of the members of the West Bengal Education Service joined the West Bengal Homeopathic Health Service in Scale No.16 and later shifted to West Bengal Homeopathic Education Service(Initially they were appointed in the scale of Pay of 1640-65-100-365/- ,subsequently which became Rs. 15600-42000/-,Grade Pay of Rs.5400/-) and also revised at Rs. 56100/- to 144300/- under WBS(ROPA) 2019 on the basis of recommendation of Public Service Commission, West Bengal and West Bengal Health Recruitment Board respectively after getting 8 years benefit of MCAS 2001. The matter of admissibility of 25 years Career Advancement in PB-5 (Rs.37400 - Rs.60,000 with Grade pay Rs 8700/-) subsequently revised under WBS (ROPA) 2019 of some of these service doctors is under active consideration of this Government for sometimes past as they have already enjoyed their promotional benefits of Reader-Professor.

After careful consideration of the matter, the undersigned is directed by order of the Governor to say that the Governor is pleased to accord approval to the admissibility of 25 years benefit in respect of the teaching faculties of Homeopathic Education Services as follows :-

1. The members of West Bengal Homeopathic Education Service, who joined West Bengal Homeopathic Health Service in scale no.-16 and later shifted to West Bengal Homeopathic Education Service, shall on completion of 25 years of service counting from initial appointment in the W.B.H.H.S , are entitled to move to Level-21 subject to fulfillment of other criteria as mentioned in Memo No. 3015-F dt.13.03.2001 and No. 6402-F(P2) dt.07.11.2019.
2. 16 years benefit under MCAS, 2001 stated to have been allowed to the doctors in 2010 counting their service from initial appointment in the post of Medical Officers under W.B.H.H.S, shall, however , are not admissible.
3. This has the concurrence of Finance Department,Group-P1 vide UO No:Group P1/2022-2023/0311 UO Date 09/11/2022.

Director of Homeopathy is hereby requested to act accordingly after maintaining norms strictly as laid down in Finance Department Memo No. 3015-F dt. 13.03.2001 and No. 6402-F(P2) dt. 07.11.2019 as regard to Sl. No. 1 mentioned above & to take necessary action for recovery of overdrawl amount involving in 16 years benefit under MCAS'2001 regarding Sl. No. 2 above respectively .
