NOTIFICATION


The post of District Medical Officer (AYUSH) had been created for proper implementation and monitoring of AYUSH related activities throughout the State vide order no. HF/O/AYUSH/519/3H-269/2014 dt 04.08.2015.

In this connection a separate office has been set up for District Medical Officer (Ayush) in each district and five posts including the post of District Medical Officer (Ayush) are also sanctioned for manning such office in each district.

Since the AYUSH activities are gradually increasing at the ground level day by day, it has been decided, with the approval of the appropriate authority of the department, that:-

- i. The officer appointed as the District Medical Officer (Ayush) will take over full charge of the office of the District Ayush set up.
- ii. District Medical Officer (AYUSH) will report to the Chief Medical Officer of Health of the concerned district.
- iii. The District Medical Officer (Ayush) will remain responsible for timely compliance of department's orders & instructions given time to time regarding collection and compilation of various data, implementations of AYUSH activities and co-ordination with Chief Medical Officer of Health of the concerned district.
- iv. Expenditure towards salary of District Medical Officer Ayush & other staff and all other expenditure in connection with the maintenance of the office of the district Ayush set up will be debitable from head of account "24-2210-04-101-NP-001" (Ayurved) and "24-2210-04-102-NP-001"(Homoeopathy).
- v. The Drawing & Disbursing Officer under the CMOH will act as the Drawing & Disbursing Officer in r/o the district Ayush set up.


