ORDER

Smt. Suparna Ray Dās, Staff Nurse, Gr-II attached to Mathurapur RH and Smt. Supriti Mondal, Staff Nurse, Gr-II attached to Baruipur SDH/ SSH were released as Trainee Reserve to undergo M.Sc.(Nursing) course for the session 2021-2023 at Govt. CON, NRS MC&H, Kolkata and at Govt. CON, ID & BG Hospital respectively vide memo no. HFW-37099/123/2020-DIR-Nursing SEC-Dept./327, dated 16.03.2022.

Thereafter in connection with this Directorate's order no. HNG/4P-05-2022/1103, dated 24.08.2022, Smt. Suparna Ray Das and Smt. Supriti Mondal were promoted as Sister-in-charge and the concerned Nursing Personnel were released during their TR period by their respective District Authorities to join their promotional posting as Sister-in-Charge, Gr-I(ii) at Kakdwip SDH/SSH within Diamond Harbour Health District, without having any valid release order from their respective College Authorities. Moreover Smt. Suparna Ray Das has joined on 27.08.2022 and Smt. Supriti Mondal has joined on 30.08.2022 as Sister-in-Charge, Gr-I(ii) at Kakdwip SDH/SSH in violation of this Directorate's order nos HNG/4P-03-2022/1124, dated 31.08.2022 and HNG/4P-03-2022/1335, dated 12.10.2022.

Now after considering all related aspects ,and after having heard their submissions the joining of the above noted Nursing Personnel in their promotional posts as Sister-in-Charge, Gr-I(ii) in Kakdwip SDH/SSH is hereby disallowed as TR permission was issued in favour of them as Staff Nurse, Gr-II and they must continue their M.Sc.(Nursing) course under TR category as Staff Nurse, Gr-II as per TR Rule.

However, the incumbents will draw pay & allowances as Staff Nurse, Gr-II till completion of their M.Sc.(Nursing) course.

Both the incumbents will however draw their pay & allowances as Sister-in-Charge, Gr-I(ii) with effect from their date of joining at Kakdwip SDH/SSH, Diamond Harbour Health District , only after completion of their M.Sc.(Nursing) course as TR candidates and only after taking proper release from their respective Colleges.

Therefore, the Superintendent, Kakdwip SDH/SSH is hereby directed to disburse their pending pay & allowances as Staff Nurse, Gr-II immediately and continue it till completion of their M.Sc.(Nursing) course and subsequent joining in Kakdwip SDH/SSH as Sister-in-Charge, Gr-I(ii) after observing due procedure.
