NOTIFICATION


The Governor has been pleased to allow Dr. Manidipa Das, Dental Surgeon of the West Bengal Dental Service who has completed 16 (Sixteen) years of continuous and satisfactory service from the date of her regular appointment in the said service with one advancement to next higher scale of pay and now enjoying the scale of pay of Rs. 10,000 – 15,525/- (Scale No. 17 under ROPA, 1998) and its corresponding revised Scale of Pay Band – 4A, Rs. 15,600-42,000/- + Grade Pay of Rs. 6,600/- taken together, to move to the next higher scale of pay of Rs. 12,000-375-18,000/- (Scale No. 18 under ROPA, 1998) and its corresponding revised Scale of pay, Band – 4B, Rs. 28,000-52,000/- + Grade Pay of Rs. 7,600/- under W.B.S. (ROPA) Rules, 2009, with effect from 22-08-2022 and to allow her to continue in her present place of posting until further orders.

2.The above benefit has been awarded under the modified career advancement scheme in terms of the Finance Department's Memo No. 3015-F dated 13.03.2001. Besides, the said Dental Surgeon would also be entitled to the pay and allowances as admissible to her in terms of rules & orders of the State Government in force from time to time.

3.While giving the effect to the above benefits to the concerned Dental Surgeon, the date of her joining in the West Bengal Dental Service on regular basis, and not on adhoc basis, as also continuity of the service should strictly be verified by the head of the institution vis-à-vis the entries in her Service Book. Discrepancies, if any subsequently been found, shall immediately be brought to the notice of this Department for taking further necessary action prior to giving effect to this order in respect of the said concerned Dental Surgeon.
