Sub- Supply & Installation of 2(two) nos. Arsenic Treatment Units with existing tube wells/ overhead tanks at Behrampore Mental Hospital, Murshidabad

MEMORANDUM

The Executive Engineer, PHE Dte., Murshidabad Division, vide his memo no. 864/MURD dated 16/5/2018, has submitted an estimate of Rs. 2,12,520/- (Rupees Two lakh twelve thousand five hundred and fifty) only for supply & installation of 2(two) nos. Arsenic Treatment Units with existing tube wells/ overhead tanks at Behrampore Mental Hospital, Murshidabad and requested to place the necessary fund.

Now, as per demand of the Executive Engineer, PHE Dte, Murshidabad Division, the Governor has been pleased to accord administrative approval for **Rs. 2,12,520/- (Rupees Two lakh twelve thousand five hundred and fifty)** only for supply & installation of 2(two) nos. Arsenic Treatment Units with existing tube wells/ overhead tanks at Behrampore Mental Hospital, Murshidabad to the **Chief Engineer, Head Quarter, P.H.E. Dte. Govt. of West Bengal**, New Secretariat Building, 7th.Floor, I.K.S. Roy Road, 700001 and he is authorized to sub-allot the fund to the Executive Engineer, PHE Dte, Murshidabad Division, 4. C.R. Das Road, Behrampore, Murshidabad for execution of the work.

The fund is released subject to (i) strict observance of all relevant Financial Rules & Regulations, (ii) timely completion of the work to avoid escalation of cost, (iii) non-deviation of allotted fund from approved scheme and (iv) submission of utilization certificate of the fund allotted.

The charge is debitable to the head, **"24-HF-4210-01-800-Other Expenditure-State Development Schemes-021- Mental Hospitals(HF)- 53- Major Works/ Land & Buildings"** in the current financial year 2017-18.

This order is issued in exercise of power delegated under Finance Department Memo. No. **1872-FB**, dated 26/03/2018 and vide U.O. No. 770 dated 16/07/2018 of Financial Advisor Branch, Health & Family Welfare Department.




