ORDER

WHEREAS **Late Dr. Ranjan Kumar Panigrahi**, Ex-G.D.M.O. lastly attached to Phansidewa BPHC, Darjeeling was placed under suspension w.e.f. the date of detention by the Naxalbari P.S., i.e. 02.02.2017 vide this Department's Order No. HF/O/MA/1123/1R-156-2017 dt. 21st August, 2017 in connection with Naxalbari P.S., Case No. 29/17 dt. 02.02.2017 u/s 376 I.P.C and subsequently detention in Police Custody for a period more than 48 hours.

AND WHEREAS, Dr. Ranjan Kumar Panigrahi, Ex-GDMO of Phansidewa BPHC, Darjeeling, S/O, Late Ratanlal Panigrahi of East Babu Para, P.S.- Naxalbari, Dist-Darjeeling died in harness on 08.09.2020.

AND WHEREAS, the Court of Ld. Additional Chief Judicial Magistrate, Siliguri passed an order vide G.R. No. 347/2017 dt. 26.07.2021 stating "that considering the role accused person of this case namely Dr. Ranjan Panigrahi has expired on 08.09.2020, it is ordered that let this accused be filed for ever from this case. Let this case be dropped. "

AND WHEREAS, the Governor is the appointing authority in respect of the post held by the said Late Dr. Ranjan Kumar Panigrahi;

AND AS SUCH, in pursuance of the above said Court's order dt. 26.07.2021, the Governor is pleased to order that:

- (i) The order for placing Late Dr. Ranjan Kumar Panigrahi under suspension be revoked with effect from the date of his death i.e. 08.09.2020
- (ii) The period of suspension will be treated as the period spent on duty.
