

### MEMORANDUM

The undersigned is directed to say that a proposal for charging fees for utilizing infrastructural and technical facilities of Government Medical / Dental Colleges and Government Hospitals from various categories of applicants as mentioned below in the given table was under consideration of this State Government for sometime past. It was also under consideration to permit the 'Heads of Medical / Dental Teaching Institutions and Superintendents of Government Hospitals' to allow applicants to join their respective Institutions / Hospital for various types of trainings or for other matters as stated below in the table without having to seek 'Permission / No Objection Certificate' from the Director of Medical Education, Government of West Bengal or the Director of Health Services, Government of West Bengal.

2. After carefully considering all aspects in these regards the undersigned is directed by the order of the Governor to say that the Governor is pleased to permit Heads of the Government Medical / Dental college and Superintendents of the Govt. Hospital of this State to allow the various categories of applicants to pursue various trainings or other matters after charging the amount of fees as mentioned below in the given table and also subject to such terms and conditions as mentioned below:

#### (A) Fee-structure:

Sl. No	Category of applicants	Period of Training & nature	Amount of fees to be paid by applicant.
1	All 'Para Medical' Diploma / Degree holder candidates like DMLT, DPT, B.Opt., DPT etc.	6 (six) months Internship	Rs. 500/- (Rupees five hundred) only per month per candidate.
2	All 'Nursing' Diploma / Degree holders	6 (six) months Internship	Rs. 500/- (Rupees five hundred) only per month per candidate.
3	All Nursing / Paramedical / Homoeopathic / Ayurveda / Unani Institutions or any 'Hospital' for Para-clinical or clinical attachment / laboratories facilities / Observation of Post Mortem cases or any other 'Training' for batches of their students or personnel	6 (six) months (maximum)	At the rate of Rs.100/- (Rupees one hundred) only per month per student

4	'Research work / Collection of data or any other material, for preparation of 'Project etc.' from individual other than students of Govt. Medical / Dental Institution and other Govt. Health related Institutions of the State;'	6 (six) months (maximum)	(i) Rs. 2000/- for duration of 1 (one) month or less per student. (ii) Rs. 3000/- for duration of more than 1 (one) month and less than 3 (three) months per student. (iii) Rs. 5000/- for duration of more than 3 (three) months and up to 6 (six) months per student.
5	Applications from individual other than students of Medical / Dental Institutions affiliated to WBHS, Kol. or from any health related 'Organization / Company' for getting clearance from 'Ethical Committee of Govt. Medical / Dental Colleges' for his / their 'Research Project(s)'		Rs. 5000/- (Rupees five thousand) only per 'Research Project'

## (11) Terms and conditions:

(a). The individual applicant must hold a Degree / Diploma from an Institution affiliated to The University / State Medical Faculty and recognized by Statutory Bodies like MCI, DCI, CCH, State Medical Council etc. and the applicant Institutions must be affiliated to the University / State Medical Faculty and recognized by Statutory Bodies like MCI, DCI, CCH, State Medical Council etc.

(b). No accommodations shall be provided to the applicants in campus of concerned Govt. Institutions or Govt. Hospital.

(c). Suitable penalty shall be imposed on the individual student / trainee and also on 'Institutions' whose students shall cause damage to the properties of Govt. Institutions / Hospitals.

(d). Presence of students / trainees shall not impair normal functioning of Govt. Institutions / Hospitals.

(e). There shall be no blaming on the concerned Head of Institutions or on the concerned Superintendent of the Hospitals to permit all applicants.

3. The amount of fees or charges so collected shall be deposited to the 'Raj Kalyan Sanstha' of the respective Govt. Medical / Dental Institutions and to the 'District Swasthya Samiti' of the Govt. Hospitals under control of respective CMOs.

4. This arrangement shall be effective from the date of issue of this memorandum.

5. This order issues with the concurrence of the Finance (Audit) Department U.O. No. 278 Group 'O' dated 13/5/08.
