Sir,

With reference to the above, the undersigned is directed to inform that as per concurrence Finance Dept., Govt. of West Bengal vide U.O. no. 67 F(Pen) dt. 10.03.2021, that this Govt. has neither any provision nor right to count past service of a Govt. employee who have rendered service to this Govt. for certain period and finally has been absorbed to Central Govt./Central Autonomous Body. His past service will be counted by Central Body (i.e. The IIT Kharagpur) where, Sri Jyotirmoy Chatterjee has been absorbed through proper channel.

However, the pensionary benefits and other liabilities may be remitted either to the incumbent for the period (on & from 01-11-1980 to 07-05-2007) he rendered under the Directorate of Health Services, Govt. of West Bengal as he fulfilled the conditions as per Finance Deptt. Memo No.7091-F, Dated: 19-07-1986 for absorption under Central Body, or we may remit the commuted value of entire pension and retirement benefits to the present employer (i.e. IIT Kharagpur), so that the present employer may count his entire period of service for providing him pension on superannuation.

Necessary action may now be taken in this regard for remittance of Pensionary benefits and other service liabilities of Sri Jyotirmoy Chatterjee to IIT Kharagpur.
