He previously prayed for discontinuation of bond service by paying penalty amount but now he wants to resume his duty.


He is allowed to resume his duty within Seven days from the date of issuance of this order as mentioned in column [C].

The academic documents of the above mentioned candidate will be released only after his competition of bond period.


