ORDER

It was decided that like previous year extensive awareness campaign on "prevention and management of Dengue" would be taken up by I & CA Department all over West Bengal from August 2020 to November 2020.

District Information and Cultural Officers (DICOs) have been directed by Director. Information to put up permanent and temporary hoardings in different municipal and GP areas. They have also been directed to undertake extensive miking for awareness campaign on dengue prevention.

Accordingly, Director, Information has sent district wise requirement and requested this Department for release of fund vide his Memo No. 1749/ICA(N) dtd 31.7.2020.

In view of above, the undersigned is directed by order of the Governor to say that the Governor has been pleased to accord Administrative Approval and Financial Sanction to the tune of Rs 2,02,02,514 (Rupees two crore two lakh two thousand five hundred fourteen) in favour of the concerned District Information and Cultural Officers as per break up furnished by Director, Information. Out of the total sanctioned amount, Rs 1,40,92,522 is debitible from the head of account 24-2210-06-800-002-50-00 in the current Financial Year 2020-21. The balance amount of Rs 61,09,992 would be placed from Head of Account 24-HF-2210-06-101-00-013-50 in the current Financial Year 2020-21. Head of Account wise break up is also detailed in the annexure.


District Information and Cultural Officers will act as DDO in respect of the fund being placed.
