ORDER

Smt. Hasi Banerjee, Staff Nurse, Gr. II, attached to Katwa S.D. Hospital, Purba Bardhaman was absent from her duties for 177 (one hundred seventy seven) days w.e.f 08.03.2017 to 31.08.2017 due to treatment of pulmonary tuberculosis. She has been allowed to resume her duty on 01.09.2017.


The Special Medical Board has recommended the sanctioning of her Special Disability Leave for 177 (one hundred seventy seven) days w.e.f 08.03.2017 to 31.08.2017.

Accordingly, her said period of absence is hereby regularized by granting leave in the following manner:-

- a) Special Disability Leave with full pay for 120 (one hundred twenty) days w.e.f 08.03.2017 to 05.07.2017 terms of Rule 195 (7) (a) of WBSR, Part-I.
- b) Special Disability Leave with full pay for 57(Fifty seven) days w.e.f 06.07.2017 to 31.08.2017 in terms of para of Rule 195 (7) (b) of WBSR, Part-I. The 57(Fifty seven) days will be treated as leave salary on full pay by combining Half Pay Leave for the remaining 57(Fifty seven) days (sanctioned as Special Disability Leave) and 57(Fifty seven) days of Half Pay Leave duly debited to her Half Pay Leave Account.

Smt. Hasi Banerjee, Staff Nurse, Gr. II had likelihood to return to her present post after the expiry of her leave and she actually did so.

All concerned are being informed accordingly.


