Dr. Jayanta Kumar Bhaumik, Medical Officer of Nabadwip S.G. Hospital was allowed premature retirement on memo: Pen-134/NSGH/261 dt.07.04.2021, from your office.

Senior Accounts Officer /Pen X of the office of the Pr. A.G. West Bengal returned the service book of Dr. Bhaumik, **seeking some clarification from Superintendent, Nabadwip SGH** bearing memo no. Pen.X/CH-1/P/20/10/462744/1021246032/P/21/10/284240 dated 12/03/2021.

In response to the queries, it may be stated that due to impairment of hearing, Dr. Jayanta Kumar Bhaumik **discontinued his service from 01/08/2018** which was subsequently placed before Zonal Medical Board of Medical College, Kolkata. **The board issued the certificate on 12/12/2018. But Dr. Jayanta Kumar Bhaumik last attended his duty on 31/7/2018.**

Considering his last date of attendance on 31/7/2018, his date of effect of premature retirement was decided on the same day, i.e 31/7/2018, in spite of the later date of Medical Certificate. This has the approval of higher authority and Hon'ble MIC.

Also in the mentioned memo of your office, *the class of pension as per rule 37 of WBS(DCRB) Rules 1971 should be mentioned in the single comprehensive form*, as desired in the said memo memo no. Pen.X/CH-1/P/20/10/462744/1021246032/P/21/10/284240 dated 12/03/2021.
