**ORDER**

Administrative Approval was accorded for the scheme 'Construction of 04{six} nos. of Non-GP Head Quarter Sub Centres at Darjeeling (GTA) District' at an estimated cost of Rs.70,04,244/- (Rupees Seventy lakh four thousand & two hundred & forty four) only, at a unit rate of Rs.17,51,061.00 per Sub Centre, vide Order Nos. HFW/NHM-378/2017/2583 dated 18.05.2018 & HFW-27011/206/2018-NHM SEC-Dept. of H&FW/3901 dated 23.07.2018.

2. Now, Secretary, DH&FWS, Darjeeling (GTA) has submitted the requisition of fund for those Sub Centres. 
6. Senior Accounts Officer, National Health Mission will act as the Drawing & Disbursing Officer for the said purpose.


