MEMORANDUM

By virtue of order no. HS-559/MA/DHS/Singly/SS(SB)/2011, dated 27/08/2011 the services of Dr. Sandip Chakraborty (**While he was in W.B.H.S.**), Assistant Professor, Department of Orthopaedics, Malda Medical College, Malda was placed under suspension for an act on 22/08/2011 for negligence in treating a patient whose lower limbs were cut off from his main body due to railway accident.

Thereafter, the suspension was withdrawn vide an order no. **1S-2562-99/504/HFW/SS(MA)/2011, dated 30/09/2011 and w.e.f. 01/10/2011.** As such the suspension period remained for 35 days (**27/08/2011 to 30/09/2011**) only.

H.S. Branch of the Department of Health & Family Welfare regularized the period of suspension as spent on duty as per Rule 72B of W.B.S.R. part I vide order No. HF/O/HS/948/HFW-43015(30)/1/2021-Admin Sec., dated 19/07/2021.

Ever since his suspension his regular increments remained stopped since July, 2012 until **abruptly he was given increment at N.B.M.C., Darjeeling on 01/07/2018**

In view of the above, the undersigned is directed by order of the Governor to say that the Governor is pleased to allow regular increments to Dr. Chakraborty with effect from July, 2012 with accrued arrears of pay if not done so far.

The Governor is further pleased to grant Dr. Chakraborty Earned Leave for the period from 01/04/2012 to 07/01/2013 u/r-169 of W.B.S.R. Part- I.

This order is issued in consultation with the Law Branch of the Department.
