

**ORDER**

Smt Khana Barman , Staff Nurse , Grade-II now posted at N.R.S. Medical College & Hospital, Kolkata was absent from her duty from 20.01.2018 to 08.02.2019 and 10.02.2019 to 17.06.2020 i.e. her total absence from duty was for 879 days because of her suffering and treatment for Sputum +ve, MDR Pulmonary Tuberculosis. She joined her duty on 18.06.2020.

After reviewing her application dated 18.06.2020 for regularization of her period of absence and other treatment documents " Medical Board on Special Disability Leave" on its meeting held on 24.08.2020 passed the following recommendation "She may be allowed total 730 days as Special Disability Leave with effect from 21.01.2018 as per Rule 195 of WBSR Part I. Hence her period of absence is hereby regularized as follows:

- i. Earned leave for 1 day on 20.01.2018.
- ii. Special Disability leave for 120 days on full pay w.e.f. 21.01.2018 to 20.05.2018.
- iii. Special Disability leave for 264 days on full pay w.e.f. 21.05.2018 to 08.02.2019 in lieu of 528 days half pay leave.
- iv. Special Disability leave for 41 days on full pay 10.02.2019 to 22.03.2019 in lieu of 82 days half pay leave.
- v. Commuted leave for 35 days w.e.f. 23.03.2019 to 26.04.2019 in lieu of 70 days Half Pay leave in terms of Rule 173 of WBSR Part I.
- vi. Earned leave for 24 days w.e.f. 27.04.2019 to 20.05.2019 in terms of Rule 173 of WBSR Part I.
- vii. E.O.L for 394 days w.e.f. 21.05.2019 to 17.06.2020 in terms of Rule 175 of WBSR Part I.


