All in-service nursing personnel having a minimum three (03) years of uninterrupted satisfactory service under the Department of Health & Family Welfare, West Bengal are directed to read the provisions laid down in TR Rules, 2009 (copy enclosed herein) carefully and have to be sure whether they are eligible as per such rule to apply to Post Basic B.Sc. (Nursing) / M.Sc.(Nursing) course for the session 2021-2023 as prescribed by the West Bengal Joint Entrance Examination Board.

Candidates are instructed to obtain a permission letter as "Allowed to appear" from their local authority before appearing the entrance examination ( JEPBN /JEMScN) if the candidate fulfills the criteria. The candidates have to keep the local permission letter with them only until any College allocation is received.

The in-service nursing personnel employed under this Government who will be allotted to any College of Nursing for admission to Post Basic B.Sc. (Ng.) / M.Sc(Nsg) course for the session 2021--2023 are instructed to submit their prayer for T.R. through proper channel with requisite documents. They must enclose the allotment letter and the declaration letter whether they have availed any Study Leave or TR earlier with enclosed proforma. Administrators are instructed to forward only those applications who have College allotment letter issued by WBJEEB.


