ORDER

Assistant Secretary & D.D.O, Department of Health & Family Welfare, West Bengal will act as DDO in respect of the fund being placed.

The expenditure will be charged upon the Budget Provision under the Head of Account "24-HF-2210 - Medical & Public Health - 01 - Urban Health Services - Allopathy - 110 - Hospital & Dispensaries - SP - State Plan (Annual Plan + 12th Plan) - 008 - Grant to Non-Government Medical Institution-[HF] - 31 - Grants-in-aid -General- 02 - Other Grants" during the current financial year 2017-2018.

This order is issued in exercise of power delegated under Finance Department Memo No.410-F.B. Dated. 23.06.2017 read with the concurrence of Financial Advisor of this Department vide U.O. No. 798 dated 30.08.17.

This has been approved by the Principal Secretary of this Department.


