In terms of Notification No. 251-Emp., Dated 03.12.2013 of the Labour Department, Government of West Bengal, the following 29 (twenty nine) candidates have been considered fit for appointment to the post of **General Duty Attendant/Sweeper** as mentioned against their names in Column III as per existing rules, (in the exempted category) in the Pay Band scale of Rs. 4900-16200/- of PB-I with Grade Pay of Rs.1700/- under W.B.S. II. The concerned MSVP/Chief Medical Officer of Health(s) / Director is/ are requested to issue **appointment order** in favour of the respective candidate(s) posting them at specific places under their administrative control against the existing vacant posts of **General Duty Attendant / Sweeper** maintaining the guidelines mentioned in Notification No. 251-Emp, Dated 03.12.2013 of the Labour Department, Government of West Bengal.


III. The appointment order must be issued within 7 (seven) working days of receipt of this order and the incumbent(s) should be instructed to join within 30 (thirty) days thereafter. The terms and conditions of the appointment should be clearly mentioned in the appointment order.

IV. The original copies of Police Verification Report and Medical Fitness Certificate in respect of the above mentioned incumbents are kept with this office and the concerned MSVP/Director/Chief Medical Officer of Health / Superintendent /B.M.O.H is/are are requested to arrange for collection of those copies from this office for future reference and records.

V. A compliance report should be sent to the undersigned within 15 (fifteen) days of joining of the appointee(s) along with the copy of joining report at the place of posting.

VI. An undertaking, as per Clause II of the Notification No. 251-Emp., dated 03.12.2013 read with Notification No. 26-Emp dated 01/03/2016 of the Labour Department, Government of West Bengal, should be submitted every year by the incumbent to the Authority.

VII. This Order is being issued with the concurrence of the competent authority and in compliance with the guidelines mentioned in Notification No. 251-Emp, Dated 03.12.2013 of the Labour Department, Government of West Bengal.


