ORDER


By virtue of authority vested in me as the Director of Health Services, Government of West Bengal and in exercise of the power conferred upon me under Rule 15 (1) (iii) of the Delegation of Financial Powers Rules, 1977, I, Director of Health Services, West Bengal, do hereby delegate powers for sanction of (i) expenditure in connection with purchases of store (Head Quarter) items, (ii) West Bengal Health for All Employees and Pensioners Cashless Medical Treatment Scheme, 2014 & (iii) Bills contingent in nature to the Additional Director of Health Services (Administration) of the Directorate of Health Services, West Bengal, as the same is considered necessary for expeditious disposal of the work of this Directorate.

2. The Additional Director of Health Services (Administration) as mentioned above will henceforth exercise financial and other powers as are hereby delegated to him subject to the condition at para 3 below.

3. Notwithstanding anything contained in para 2 above, I reserve the right to call for any file/e-file, check and pass orders thereon. The Additional Director of Health Services (Administration) as authorized shall maintain a register of sanctioned cases and put up to me once a month for my perusal or whenever asked for.

4. This has the approval of the Additional Chief Secretary, Department of Health and Family Welfare.

5. This order will take effect immediately.


