**Sub: Composition of Hospital based Authorization Committee for Organ Transplantation in respect of IPGMER-SSKM Hospital**

The hospital based Authorisation Committee for Organ Transplantation in respect of IPGMER-SSKM Hospital, Kolkata shall consist of the following members:

1. Director (or MSVP, in case of absence of the Director) – Chairperson.
- 2-3. Two senior medical practitioners from the same hospital who are not part of the transplant team (as selected by the Chairperson) - Members.
- 4-5. Two persons (preferably one woman):
  - a. One from a high integrity, social standing and credibility, who have served in high ranking Government positions, such as in higher judiciary, senior cadre of police service or who have served as a reader or professor in University Grants commission approved University – Member(as selected by the Chairperson).
  - b. Self-employed professionals of repute such as lawyers, chartered accountants, doctor of IMA, reputed NGO or renowned social worker – Member(as selected by the Chairperson).
6. Secretary, Health or nominee and Director Health Services or nominee from State Government administration – only one member,- to be nominated by Addl. DHS (Admin) and Senior Nodal Officer, TOHO Act, 1994 and Rule, 2014 on behalf of DHS & DME, WB. Director/ Nodal personnel on Organ Transplantation, IPGMER-SSKM Hospital is requested to contact well in advance to the Addl. DHS (Admin), WB in his e-mail ID ([aditikishore.sarkar@gmail.com](mailto:aditikishore.sarkar@gmail.com)) with particulars of date, time, venue, members of Authorization Committee and particulars of donor(s) and recipient(s) with their relation.

**Please note:** The **quorum** of the Authorization Committee should be minimum four and the quorum shall not be complete without the participation of the a) Chairman and b) DHS / DME nominee.
