- V ) **The place of posting not to be changed even on detailment by CMOH at any stage without approval of the undersigned.**
- VI) The concerned authority can utilize the service of any incumbent above as HC-Cashier or HC-Accountant if required.
- VII) The order is issued in the interest of public service.
