- Such appointment is made, pending completion of verification of their antecedent. Their services are liable to be terminated in case of adverse reports about their antecedent.
- The appointees will be liable for transfer to any station within the state of West Bengal in the interest of public service.
- The candidate will draw a pay as per WBS (ROPA) Rules, 2019 in Pay Matrix Level-16 read with F.D. Memo No. 5562-F(P), dated 25.09.2019, in the corresponding Pay Band (PB-4A) of ₹15,600-42,000/- plus Grade Pay of ₹5,400/- as per WBS (ROPA) Rules, 2009 read with F.D. Memo No. 961-F(P), dated 07.02.2011. Besides the grade pay, the candidate will draw other allowances as admissible to the officers of WBS.

5. The candidates shall be governed by the terms and conditions, applicable to the officers of WBGS. They shall be required to perform all such duties as may be assigned to him from time to time besides the duties of the post in which they are or may be appointed.
6. The candidate is hereby directed to report themselves for duty to the concerned M.S.V.P. immediately **within 4 (four) weeks** from the date of issue of this order positively. No T.A. for joining the post will be allowed to them.
7. No application or request for extension of joining time will be entertained and no correspondence in that regard shall be made to the applicant.
8. The M.S.V.P.s are requested to take immediate steps for medical examination of the candidate by medical boards in terms of Health Directorate's Circular No. Estt./1M-258/76/79 dated 26.06.1977 before allowing the candidate to join and to forward a copy of the Medical examination report to the Deputy Secretary (MA), West Bengal. He is also requested to verify all the testimonials relating to educational qualifications of the candidate before he is allowed to join.
9. The candidate will have to **submit two copies of filled up PVR to the office of the M.S.V.P. at the time of joining the service**, failing which they will not be allowed to join. Blank copy of PVR format may be downloaded from the Annexure-A at our website.
10. The M.S.V.P. will receive filled up PVR (two copies) from the candidate before allowing him to join and subsequently send these PVR to the Superintendent of Police of concerned district for verification.
11. If any adverse report is found during verification of PVR, the service of the candidate may be terminated.
12. The joining report of Physicist-cum-Radiation Safety Officers, who have joined on temporary basis, should be sent positively to the email ID *ds.ma.wbhealth@gmail.com* and *js.ma.wbhealth@gmail.com* of the Deputy Secretary (HS), Department of Health & Family Welfare, W.B, within 7(seven) days of their joining.
