
In terms of Order No HF/O/AYUSH/519/3H-269/2014 dated 4<sup>th</sup> August 2015, 19(Nineteen) posts of District Medical Officer (Ayush) have been created in the State of West Bengal. Presently five posts of District Medical Officers(Ayush) lying vacant/going to be vacant in the district of Alipurduar, North 24 Pdns, Dakshin Dinajpur, Paschim Medinipur & Uttar Dinajpur.

Accordingly applications are invited in the prescribed format from eligible, willing and interested Homoeopathic/Ayurvedic Medical Officers belonging to the cadre of West Bengal Homoeopathic Health Service & West Bengal Ayurvedic Health Service respectively, for ad-hoc appointment to the post of District Medical Officer (Ayush).
