ORDER

Permission is hereby accorded to appoint 34 (thirty four) stipendiary Dental House-staff through Central Selection from Swasthya Bhawan in the Dental Departments of 10 (ten) District Hospitals and 07 (seven) Medical Colleges situated in the districts except Burdwan, Bankura and Midnapore Medical College & Hospitals from the session commencing from 01-11-2019 in supersession of the previous order for local selection in this regard.

02 (two) stipendiary House-staff in each of the above-mentioned facilities as per Annexure – “A”, will be appointed for a tenure of one year in two six monthly terms from the fresh dental graduates who have completed 01 (one) year rotatory internship and are registered under DCI/WBDC. In case no candidate from the fresh batch is available, candidates of immediate previous year will be considered.

However, the local authorities are empowered to fill up the vacant posts of Stipendiary Dental House Staffs, if any, as per the existing rules upto 31-10-2019 with the approval of the undersigned.

The candidates should abide by the rules and regulations guiding the conduct of stipendiary house-staff and terms and conditions as laid down in the concerned prevailing Govt. Orders related to House staff.

It is to be treated as a Statutory Order which is to be followed every year with immediate effect until further orders.

All concerned are being informed accordingly.


