**MEMORANDUM**

1. In terms of the Notification No. HF/O/HS (MA)/837/HFW-25099/19/2019-MA Dated Kolkata, 11<sup>th</sup> June, 2021, the total Trainee Reserve for the year 2021-2022 stands at - 501 in case of PG Degree and Diploma.
2. In keeping with the above, 1 (one) officer of the West Bengal Public Health and Administrative service, as shown in the Annexure, is provisionally permitted to undertake postgraduate degree course in the discipline as noted against the candidate under the University as mentioned against his name for the session 2022-2024, and for that purpose the candidate is placed on Trainee Reserve for the period as mentioned against his name with effect from the date of his release from his present place of posting till the completion of the University examination of the course for the first time whichever is earlier.
3. He shall be released under local arrangement from his present places of posting by the concerned controlling authority in order to enable him to join his course, after handing over his official charges.
4. Meanwhile, if on scrutiny and vigilance verification the candidate is found to have been suppressing facts or furnishing false information, or in case of any adverse report, his candidature will be liable to be cancelled and appropriate administrative action will be initiated against him.
5. During the period of his placement on Trainee Reserve, the Officer will draw Pay & Allowances as admissible to him under the West Bengal Public Health and Administrative service (Cadre, Pay & Allowances) Rules, as applicable for his case, and in terms of the existing Rules of this State Government.
6. The Medical Officer, as placed on Trainee Reserve is subject to the condition that he will prior to his drawing Pay as Medical Officer on Trainee Reserve, execute bond in triplicate in the prescribed form undertaking to serve the State Government for a period of at least three years (for two years course) and at least five years (for three years course) after completion of the course. The duly filled up bond should be submitted to the HS Branch of this Department of Swasthya Bhawan for acceptance.
7. The Assistant Director of Health services (accounts) will act as the DDO in this regard and the University shall submit the requisite reports in respect of the Medical Officer, as desired by the Director of Health services, West Bengal.
8. The Pay & Accounts Officer-III, Kolkata, Accountant General, West Bengal and other concerned are being informed.
9. He will obtain release order from the concerned Institution immediately after completion of the course and report to the Director of Health Services, West Bengal for duties.
10. This order is issued in accordance with this Directorate Order No. HF/O/MA/641/HFW-25099/54/2021-MA dated 6th April 2021.
