Subject: Granting of CAS benefit after completion of 8 (eight) years of continuous and satisfactory service in respect of Smt. Rina Dutta, Clinical Instructor, College of Nursing, N.R.S. Medical College & Hospital, Kolkata.

MEMORANDUM

Smt. Rina Dutta, attached to College of Nursing, N.R.S. Medical College & Hospital, Kolkata was appointed to the post of Clinical Instructor under West Bengal General Service (Nursing) vide Notification No. HF/O/MA(MES)/4656/3R-03/07 dated 18.08.2010 based on the recommendation of PSC, WB vide No. 155-PSC(IVB) dated 12/07/2010 and joined the said post w.e.f. 21.08.2010 in the Pay Scale of Pay Band 4 (Rs. 9,000-40,500/-) with Grade Pay Rs. 4,400/- under WBS (ROPA) Rules, 2009 corresponding to Level-12 (Rs. 35,800-92,100/-) under WBS (ROPA) Rules, 2019.

2. The benefit under CA Schemes which has been due to her since 21.08.2018 for completion of continuous and satisfactory service of 08 (eight) years in the same post without any promotion on 20.08.2018. Smt. Rina Dutta, is, therefore, eligible for Career Advancement in the next higher scale of Pay in the Scale of Pay of Pay Band-4 (Rs. 9,000-40,500/-) with Grade Pay Rs. 4,600/- under WBS (ROPA) Rules, 2009 and to the Level-13 (Rs. 37,100 – 95,500/-) of Pay Matrix under WBS (ROPA) Rules, 2019 w.e.f. 21.08.2018.

3. In the circumstances stated above, the Governor has been pleased to allow 08 (eight) years' Career Advancement benefit to Smt. Rina Dutta, attached to College of Nursing, N.R.S. Medical College & Hospital, Kolkata w.e.f. 21.08.2018 in terms of F.D. Memo No. 3015-F dated 13.03.2001 read with Finance Department's Memo No. 961-F(P) dated 07.02.2011 and 6042-F(P2) dated 07.11.2019 in the following manner.

a). She is entitled to draw her pay in the Scale of Pay of Pay Band-4 (Rs. 9,000-40,500/-) with Grade Pay Rs. 4,600/- under WBS (ROPA) Rules, 2009 w.e.f. 21.08.2018 to 31.12.2019.

b). She is entitled to draw her pay in the Pay level-13 (Rs. 37,100-95,500/-) of the Pay Matrix under WBS (ROPA) Rules, 2019 notionally w.e.f. 21.08.2018 to 31.12.2019 and actually w.e.f. 01.01.2020.

4. Her new enhanced pay will be fixed as per the option exercised by her.

5. The pay of the incumbent so fixed is provisional and subject to re-paid of excess of drawl if any, due to fixation of pay as per existing rules and regulations, if detected subsequently, as per the direction of the appropriate authority.

6. All concerned are being informed accordingly.
