NOTIFICATION

The Governor has been pleased to allow Dr. (Smt.) Sudipta Sur, MO(Supy), Swasthya Bhawan, who has completed 8 (eight) years' continuous and satisfactory service from the date of her regular appointment in the said service without any promotion and was enjoying the scale of pay of Rs.8,000 - 275 - 13,500/- (Scale No.16)and its corresponding revised Scale under Pay Band 4A i.e. Rs./-15,600-42,000/-+Grade Pay of Rs.5,400/-taken together, to move to the next higher scale of pay of Rs.10,000 - 325 - 15,525/- (Scale No.17 of WBS ROPA '98) and its corresponding revised Scale under, Band-4A, 15,600-42,000/-+Grade Pay of Rs.6,600/-under W.B.S.(ROPA) Rules,2009 with effect from **27.08.2018.**

On her entitlement to the higher scale under, Band-4A, 15,600-42,000/-+Grade Pay of Rs.6,600/-under W.B.S.(ROPA) Rules,2009, the pay of the Medical Officer shall be fixed in terms of Finance Department's Memo. While giving the effect to the above benefits to the concerned Medical Officer the date of her joining the West Bengal Health Services on regular basis, AND NOT ON ADHOC BASIS, as also continuity of her service should strictly be verified by the head of the institution vis-à-vis the entries in her Service Book. Discrepancies, if any subsequently been found, shall immediately be brought to the notice of this Department for taking further necessary action prior to giving effect to this order in respect of the said concerned Medical Officer.
