The Block Medical Officer of Health, Memari Rural Hospital, Purba Bardhaman permitted for study leave, may be released by local arrangement by the Chief Medical Officer of Health, Purba Bardhaman to enable him to join the course as soon as possible. The concerned Officer would hand over charges, at the local level, as directed by the local controlling authority.
