Subject: Option for exercise of placement to serve in the Government Facilities or discharge of Indemnity Bond by PG Degree/ Diploma pass-outs of year 2019

The undersigned is directed to inform that those non-service candidates who have passed out P.G. Degree/ Diploma examination, 2019, conducted by WBUHS, and are in bond contract with the Department of Health & Family Welfare, to serve in the Government Facilities, or, to deposit bond amount for not rendering service to in the Government Facilities, are hereby instructed to exercise their option in annexed proforma, either to serve in the Government Facilities, or to deposit the bond amount.

Those who intend to exercise option to serve the rural people, are requested to appear for counseling, for choice of place of posting, at 11 a.m. on 27th, 28th & 29th May 2019, at 2nd floor Auditorium, Swasthya Bhawan, as per schedule to be published later.

Those who intend to exercise option to deposit the bond amount instead of providing service in the Government Facilities, shall apply in the specified format annexed herewith within 29th May 2019, and shall have to deposit the amount on issue of advice by the Director of Health Services within one week of such advice.

Those, who do not exercise any of the above two options within 29th May 2019, shall be deemed to be willing to render rural service, and may be posted in the existing vacancies.
